Bengal Imbroglia:

BJP's Last Minute Misfire Vs Mamata's Futile Attempt to Cover-up the Corruption.

The latest political mess created by the Chief Minister of West Bengal Mamata Banerjee by enacting two-day long sit-in-dharna at Metro Channel, Kolkata and holding cabinet meeting at public place are nothing but a futile attempt to cover-up the involvement of TMC leaders in the Sarada and Rose Valley scams. It has nothing to do with the legal process going on in the Supreme Court.

It is known to all that all the successive governments have misused the CBI, the leading investigating agency of our country for their nefarious interests with political targets. The Supreme Court has ordered the CBI to enquire the Sarada scandal in 2014. Between these five years the CBI has send only two or three letters to the Kolkata Police Commissioner, who was the head of the Special Investigation Team (SIT) set up by the Bengal government to probe this corruption case. Keeping silence for 59 months, when the Lok sabha elections are at door steps, the CBI went to Kolkata to question the Police Commissioner, which is, no doubt a political game in connivance with the ruling clique. If the CBI is so keen to question the former SIT head, why they didn't complaint to the Apex Court that the Commissioner is not cooperating the enquiry and an order is required to interrogate him.

The Supreme Court order on 5th February 2019 is a blow to both the state and central governments. Now, the Police Commissioner who got extra ordinary patronage from the Chief Minister has to appear before the CBI with all evidences he collected when he was the head of the SIT. At the same time, the CBI can only question him but they cannot arrest him even if he hides the facts, according to the Supreme Court order.

All these incidents amply prove that the whole episode since 3rd February is a drama according to a mutually agreed screenplay by the BJP and TMC to cover up the huge rally of the Left Front at Brigade Ground. By enacting this drama, the TMC is posing itself as the only force in the state to oppose the BJP and Narendra Modi and the BJP is posing itself as the major force to fight against TMC rule. By doing so both of them are planning to sideline the Left Front of Bengal. But the Brigade rally of Left Front showed that the Left Front is still the major opposition in the state and the credibility of the Front is still unaffected among the general public. The All India Forward Bloc salutes the comrades, activists, sympathizers who participated in the said Brigade rally against all odds and hindrances created by the ruling party of the state.

The All India Forward Bloc all along demanded that the money looted from the general public by the ponzi chit funds and other companies with the covert and overt support

from the ruling TMC must be returned with interest and the culprits who looted the money should be punished. The CBI should speed up the enquiry and ensure the justice to the victims who lost their entire livelihood due to the scandal.
